Agenda item 2 was the Pledge of Allegiance.

Agenda item 3 was roll call. Those present were Council Members Cohrs, Fisher, Sporrer and Scheuring and Mayor McDonald. Council Member Moss was absent.

Agenda item 4 was to approve the agenda. Motion was made by Fisher and seconded by Sporrer to approve the agenda. 4 ayes.

Agenda item 5 was to open the Public Hearing to hear comments for or against approving the FY 2020-2021 Proposed Maximum Property Tax Levy. There were no comments.

Agenda item 6 was to adjourn the Public Hearing concerning the FY 2020-2021 Proposed Maximum Property Tax Levy. Motion was made by Sporrer and seconded by Cohrs to adjourn the Public Hearing concerning the FY 2020-2021 Proposed Maximum Property Tax Levy. 4 ayes.

Agenda item 12 was to approve Resolution 20-06: A resolution adopting changes to the Employee Handbook. All City of Logan Police Officers will be required to live within ten miles of the city limits of the City of Logan, IA. The City Council may specify a timeframe

within which a police officer will have to move within ten miles of Logan, IA. The resolution also states that Police Officers living beyond ten miles of the city limits of Logan will not be allowed to take any police vehicle home without prior City Council approval and that they must abide by all traffic laws in their personal vehicles. This resolution also changes the Hours of Work for the Street and Water Departments from 7 a.m. to 4 p.m. to 7:30 a.m. to 4 p.m. with a 30 minute lunch break. Motion was made by Sporrer and seconded by Scheuring to approve Resolution 20-06: A resolution adopting changes to the Employee Handbook. 4 ayes.
